**FINANCE:** The Fiscal Year 2019 EMS Assistance Grant application period is now closed. The next step is for the regional EMS System Coordinators to review the applications. Announcements should come out, assuming the state funds the grants, in the fall of 2018.

<u>LOGISTICS:</u> Reminder: If you navigate to <u>www.sirems.com</u> and receive a security alert, simply choose to continue to the site. The site is completely safe, it is causing this problem because it's built on an old format. A new site is being built.

First Responders: The draft set of new FRD/EMR protocols are complete and have been submitted to IDPH for approval. They are in flow chart format and will be separate from the BLS, ILS, and ALS protocol sets. They include the new scope of practice changes and should be easier to use.

The EMS Office strongly encourages all EMS agencies to join the Shawnee Preparedness and Response Coalition (SPARC). SPARC is a whole community coalition that has representation from EMS, healthcare facilities, law enforcement, fire, EMA, Public Health, government, and private businesses. John A. Logan College has eliminated the EMS tuition waiver program for the EMT and Paramedic classes, effective summer semester 2018. This means EMT students will be subject to full tuition for the fall 2018 semester (EMT 111) and the Paramedic students will be subject to full tuition for the summer 2018 semester (EMS 252). NASEMSO (the National Association of State EMS Officials) announced the availability of *Evidence-Based Guidelines for Fatigue Risk Management in Emergency Medical Services*. With funding from NHTSA's Office of Behavioral Safety Research and in collaboration with researchers at the University of Pittsburgh, the results of the systematic review of literature have been completed and evaluated via the GRADE process. Recommendations from a team of experts have been published early online in Prehospital Emergency Care. While the recommendations might seem intuitive, these guidelines provide a body of evidence to support them, an important first step towards reducing the effects of fatigue in the EMS industry. The project also establishes a framework for future research to inform sound EMS decision-making. This is the opportunity for all of us to give our opinions on rule changes during consideration and prior to IDPH implementation.

<u>OPERATIONS:</u> IDPH has released a warning on severe bleeding risks with the use of synthetic cannibanoids like bath salts, K2, Spice, etc. As of April 5<sup>th</sup>, there have been 89 reported cases with two deaths. Blood tests have shown the presence of brodifacoum, a lethal anticoagulant often used as a rodenticide, or rat poison. Cases have presented with various forms of bleeding, including persistent nose bleeds, blood in the urine or stool, vomiting blood, significant bruising, heavy menstrual periods, as well as with intra-cranial bleeding. Some cases have been hemodynamically stable, whereas others have been critically ill at presentation. The full IDPH memo has been posted on www.sirems.com.

The EMS System measures the amount of time it takes from call received to enroute to the scene. If you have a delay from call received to enroute, the reason needs to be documented in the run report. There are many reasons from on call staff response to delays with transferring care of another patient. If you don't document the reason for the delay, it will probably be assumed you wanted to finish watching Spongebob Squarepants....so please document the reasons for the delays.
