SIREMS is currently working on a new system policy requiring our EMS System participating agencies become a member of the Shawnee Preparedness and Response Coalition. SPARC membership is a free opportunity for networking, information sharing, assistance with planning and preparedness, and grant opportunities. All SIREMS Agencies: The EMS Office will be distributing IDPH mandated Letters of Participation in the coming days. IDPH is mandating the completion of these forms and signatures of the agency managers/administrators to update all state EMS System plans. The documents will be distributed by email soon. If your agency has any questions, please let us know.

EMS Instructors: We will be hosting a GoToMeeting soon to break down the new IDPH EMS education rules and how they will effect current programs and future training applications.

How many of our EMS Agencies have their agencies participating in PulsePoint? PulsePoint is a smartphone app that shows a GPS location of a cardiac arrest event and AED locations. This can be used by people trained in CPR and AED to assist a cardiac arrest victim prior to EMS arrival. The EMS Office is just starting to look into this application and we are curious if any SIREMS agencies use the app.

Non-Transport Agencies: Please complete the annual self-inspection forms and return them to the EMS Office as soon as possible. The self-inspection form is available on the system website, under the IDPH Forms link.

<u>OPERATIONS:</u> ILS and ALS: SIREMS has added the II-45 Self Adhering Wrap (Coban) protocol. Coban can now be used by Intermediate and Paramedic services to secure IV sites in the event tape is not adequately adhering and securing the site. Coban can be placed too tightly causing circulatory issues, so use caution when applying self adhering wrap. The SIREMS protocol ONLY allows Coban use for securing an IV site that cannot be properly secured with tape. Contact the EMS Office with questions.

The EMS System's website is in the process of being rebuilt. During this time, we cannot update the alphabetical protocol index. The protocols that are listed in the original system plan indexing format (the letter/number style) are current. The alphabetical index has not been updated since late last year. When seeking protocols on our website, do not use the alphabetical index.

If you haven't enrolled yet, don't forget to sign up for free text message alerts from SIREMS. We offer both email and text alerts for our participants, but you must enroll to receive them. The text messages are less frequent than our emails an mainly used to disseminate important information quickly.
