SUBJECT: Continuing Education Relicensure Recommendations

Please find attached the finalized Continuing Education Relicensure Recommendations. This outline replaces the former continuing education outline. The outline provides clarification of what type of hours can be earned or awarded. It also gives a breakdown of how to calculate hours based on new minimum recertification hours that differ from EMT, AEMT, EMTI and Paramedic.

There has been a change in how college courses are given credit (1 college credit=8 CEU hours) for appropriate healthcare-related courses. There is also an expansion of the utilization of online courses for approved CEU. The document addresses recommendations for Core Content breakdown by topic and hours over a four-year licensure period. This is in alignment with national recommendations.

Please keep in mind that this guideline addresses only the minimum required CEU hours for relicensure. An EMS Medical Director may still require hours above the minimum and/or the content of the CME required. Each individual functioning in an IDPH-approved EMS System should check with their EMS System Coordinator to clarify their System's specific requirements regarding renewal Continuing Medical Education.
